**PETITION FOR REFERENDUM**

We, the undersigned, being duly qualified and registered electors of the County of DuPage, State of Illinois, equaling in number at least 8% of the total number of votes cast in DuPage County, State of Illinois, for all candidates for governor in the preceding gubernatorial election, who have affixed our signatures in our own proper persons to this Petition, hereby PETITION, pursuant to Article 7, Section 11 of the Illinois Constitution and Section 28-6 of the Illinois Election Code, that there be submitted to the electors of the County of DuPage, for approval by a majority of the electors in the county voting on the question, at the General Election to be held on November 7, 2006 in the manner provided by law, the following proposition:
